

**ADVERTISEMENT NO. 01/2018**

**OFFICE OF THE DISTRICT LEGAL SERVICES AUTHORITY, DARRANG, MANGALDAI.**

Applications are invited from the local residents in bio-data format along with two numbers of passport size photographs, for selection of around 50 numbers of PLVs, who are willing to serve as a Para Legal Volunteer at Darrang District under District Legal Services Authority, Darrang. The applicants should have the following qualifications to apply for the selection of Para Legal Volunteers- :

1. He/She must be citizen of India and a local resident of the Darrang District.
2. The applicants should pass minimum matriculation with a capacity for overall comprehension and should have mind-set to assist the needy in society coupled with the compassion, empathy and concern for the upliftment of marginalized and weaker sections of the society. They must have the unflinching commitment towards the cause which should be translated in to the work they undertake. The applicants can be from the following groups:
  - a) Teachers (including Retired Teachers)
  - b) Retired Govt. Servants and Senior Citizens
  - c) MSW students and teachers
  - d) Anganwadi Workers
  - e) Doctors/Physicians
  - f) Students & Law Students (till they enroll as lawyers)
  - g) Members of non-political, service oriented NGOs and Clubs
  - h) Members of Women Neighborhood Groups, Maithri Sanghams and other Self Help Groups including of marginalized/vulnerable groups
  - i) Educated prisoners with good behavior, serving long term sentences in prisons
  - j) Any other person whom the District Legal Services Authority deems fit to be identified as PLVs.
3. Preferably the PLVs shall be selected, who do not look up to the income they derive from their services as PLVs, but they should have a mind-set to assist the needy in the society.
4. The minimum age for the selection of Para Legal Volunteers should not be less than 21 years as 01-01-2018
5. The work of PLVs doesn't carry any salary, remuneration or wage except remuneration fixed by the District Legal Services Authority, Darrang from time to time, as per rules.
6. The filled up application should reach the office of the Secretary, District Legal Services Authority, Darrang on or before **30-04-18**. The applicants should submit their mobile/contact number, email id in their bio-data format for further communication, if any.
7. Incomplete application will be rejected without assigning any reasons. No applications will be entertained after the last date fixed.
8. The decisions of the Selection Committee in short listing the number of candidate for interview and selection of PLV shall be final. The eligible candidates shall have to appear for interview before the selection committee, the date of which will be notified in the official website as given below.
9. Selected PLV shall be required to undergo training programme as per decision of the District Legal Services Authority, Darrang
10. In case of any objection regarding selection of PLVs, the decision of Chairman, District Legal Services Authority, Darrang shall be final and binding to all concerned.

11. List of shortlisted applicants, if any, will be notified in the official notice board as well as uploaded in the official website of District Judiciary, i.e., [www.darrangjudiciary.gov.in](http://www.darrangjudiciary.gov.in) for interview.
12. Canvassing directly or indirectly will disqualify the candidate.
13. No TA/DA will be provided for appearing in the interview.
