The candidate must be a holder of a valid driving license of LMV	Unreserved	The post is purely temporary on contingency basis and shall liable to be terminated at any time.

### Terms & Conditions:

1. Candidates must be an Indian Citizen as defined in Article 5 to 8 of the Constitution of India.
2. Candidates serving in Govt. Department should submit their application through proper channel.
3. If any candidate is found to have suppressed his educational qualifications or given wrong information, at the time of applying for job or later on, his candidature shall stand rejected without any information to him with immediate effect and shall also be liable to Criminal Prosecution as per law.
4. Candidates must not be less than 18 years or more than 40 years of age on 01-11-2021. In appropriate cases, relaxation of age will be admissible as per existing rules of the government of Assam.

The application with self-attested copies of all testimonials regarding Educational Qualification, Age, Caste, Professional/Transport Driving License, Experience Certificate & Character Certificate along with 3 (Three) copies of recent passport size photographs, duly signed by the candidate on the reverse side, should reach the Office of the undersigned.
